Risk and liability statement



- 1) Wild Voss AS is an adventure company based in Voss, Norway. According to Norwegian laws (*), providers of organized outdoor adventures must conduct and document systematical and continuous risk-mitigating and risk-reducing measures (internal control). This document is a part of our internal control system.
- 2) In this document, all our products, services and activities are referred to as «activities». In this document, we refer to all customers on our activities as «participants». Non-paying customers and minors (under the age of 18) are also included in this definition.
- 3) All of our activities have a designated start time (meeting time). Wild Voss AS accepts no liability or responsibility for events, mishaps, accidents or injuries occuring prior to the announced start time.
- 4) Our activities do not have a designated end time, only an estimated duration. The duration of an activity could vary from day to day, as a result of factors such as weather, route conditions, road closure, physical fitness of participants and other unforeseen factors or events. As a participant on our trip, you accept that the total duration of an activity may vary and last longer than anticipated.
- 5) Our activities end when our guide announces the end of the activity. For activities including transportation of participants, the activity ends immediately after the participant have reached the agreed destination. Wild Voss AS accepts no liability or responsibility for delays, events, mishaps, accidents or injuries occuring after the announced end of an activity.
- 6) In this document, «wild nature» refers to outdoor areas with limited or no man-made infrastructure, and with limited or no safety installations. «Wild nature» is a complex natural evironment where all variables concerning risk and safety cannot be foreseen. Consequently, travel in «wild nature» has real, inherent risks associated with it.
- 7) Wild Voss AS hereby declares that all our activities are in accordance with Norwegian laws and regulations. Participants on our activities agree that all legal disputes arising from (but not limited to) misconduct from our side, including any accident, damages or injury related to our activities will be handled inside the Norwegian body of justice and tried under Norwegian courts of law only.
- 8) Our ability to deliver the agreed-upon activities are stated in a separate document called «Terms of service». As a participant on our trips, you hereby accept these terms of service.
- 9) Wild Voss AS is an adventure company, offering a series of activities in wild nature. Consequently, we frequently travel away from roads, marked paths, mobile reception, safety installations and emergency services. Participants joining our activities understand that in wild nature, safe travel depends on (but are not limited to) the following safety practices:
 - a. Following the instructions of the guide(s) at all times.
 - b. Take an active role in assessing your own ability, both physical and mental, to complete the activity.
 - c. Wearing and using the proper and agreed-upon clothing, footwear and safety equipment.
 - d. Reporting to your guide any fatigue, illness or injury to you or someone else in your group.
 - e. Prior to departure, informing your guide about medical concerns or known medical conditions that might possibly have an impact on the safe execution of this activity.

10) Prior to departure, your guide will inform you about possible risks and how to mitigate them during the activity. Wild Voss AS and our guides will work hard to avoid discomfort, damage, accidents and injury during the activity. Note that there will still be risks present, with the potential of discomforts and injuries such as (but not limited to): fear, anxiety, fatigue, sunburn, insect bites, cuts, bruises, fractures, loss of consciousness, paralysis, permanent disability or even death. By signing this document you accept the risks involved in the activity.
